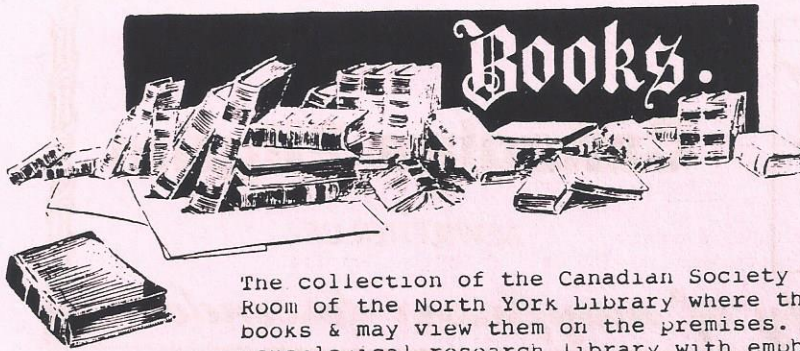

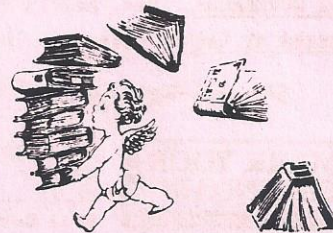

Society News

MINUTES OF THE ANNUAL MEETING



The Annual Meeting & Compact Luncheon was held 13 Nov. 1993 at the Howard Johnson Hotel in Oakville, Ont., with approx. 31 members & friends present. Gov. Leon Warmski opened the meeting and welcomed those in attendance

Treasurer Allyn Dean read the Necrocoloy, we lost two of our members in 1993, Eunice Watson (#110) and William Harris (#105). Mr. Dean presented the Treasurer's Report, which will appear in the Spring newsletter. He also discussed the necessity of the increase in life memberships. Two members have not paid their dues for 1992 and 1993 and therefore will be struck from the membership. We have reached member #190, of which 65 are life members, 81 regular members and 44 past members.

Susan Roser presented her Editor/Historian's Report. She mentioned that she had been Editor for 12 years and our newsletter "Canadian Pilgrim" had received three commendations from the Mayflower Quarterly. Back copies of the newsletters are available to those interested. Mrs. Roser said that this was her first year as Historian and she hoped to reach #200 by the end of the year but at present that looks dubious. Membership #195 should be achieved which will give us, for the first time, over 150 actual members, 31 new for this year. British Columbia now has 15 members, enough to form a colony. Mrs. Roser welcomed those new members who were present.

Librarian Arthur Harris gave his report and stated that 19 books had been added to the library during the year. He also thanked those who had made financial contributions and asked for further donations of books & money. Finally, he reminded all present of the location of the collection at the North York Library and of its openness to anyone interested in Mayflower research.

Mrs. Roser gave the report of the Nominating Committee and remarked that, for the first time, every position on the Board of Assistants will be filled. We will have a Surgeon from Nova Scotia and a Counsellor from British Columbia so are represented across Canada. The slate of nominees:

Keith Bain moved that the nominees be elected, seconded by Allyn Dean; unanimous vote.

A hot & cold luncheon followed the business meeting, after which Mr. Chris Raible, Toronto historian, gave a most interesting address about the connection between the Pilgrims and the history of Ontario. Afterwards he sold copies of his recent book and from the proceeds very generously donated \$60.00 toward our Library Fund.

1994 is the International Year of the Family



After such a financial disaster in 1992 we tightened up the budget and so ended up in 1993 with a gain of \$614.91 which still leaves a deficit of \$572.12 over the past five years. This gain is not all a true gain as it is due to our increased membership which in turn will be reflected in the increased charges in the General Society in 1994.

The deficit has been borrowed from the Permanent Fund which is the fund in which life memberships are deposited. This fund should be:

74 x 250 =	\$18500.00
actual	13740.00
borrowed	\$ 4760.00

So, we are still fighting a deficit.

We are now issuing permanent membership cards to all members both regular and life. Therefore we have changed the address labels so that above the name appears the Canadian membership number, the General Society number and the last year in which dues are paid to or in case of life membership it reads LIFE.

We presently are at membership number 201 which consists of 74 life memberships, 82 regular memberships and 45 that are no longer members. Of the 82 regular members, 42 have paid for 1994 and 40 have not. The membership fee remains at \$25.00 and may be sent to me at the address on the front of the newsletter.

We have studied the life membership fees further and have come up with the rates which appear on page 5 of the newsletter.

I wish to thank Ralph Ferguson for auditing my accounts for 1993.

WILLS, WILLS, WILLS...

I have just completed by fourth book on Mayflower research, tentatively titled, "Mayflower Deeds & Probates". As the title suggests, the book is a compilation of deeds, wills and probate records as found in the Bowman Files. I have spent two years transcribing these records and have been amazed at how interesting and informative these records can be. The following are some examples from the wills & probate records I have come across.



Maj. Samuel Ward of Ipswich states in his will of 29 July 1689 (or 1690) that he is about to embark "upon an expedition to Cannade/Canada by gods assistants agaiensst the Comon enemie...if I faiel in this expedition..." and asks his wife "to be as kiend to my children as I have ben to herr children". Maj. Ward did not return. The will of Samuel Williard, shop keeper of Boston, dated 13 Nov. 1709 states, "shortly designing a voyage by sea & not knowing how it may please God to dispose of me therein". His will was probated four years later, so it is not known if he returned or not. Capt. Samuel Gilbert of Berkley also "went away"; according to his probate records of 10 May 1777, he "absented himself for

near two year...volenterily went to our enimies". Judging by the date of 1777, we can be sure who "enimies" refers to! The probate records of Thomas Gould of Eastham, 26 Aug. 1791, gives us some insight as to his fate in life; his widow states he "went a voyage to sea two years ago and the vessels nor any of the ships company being 200 in number have not been heard of since, all hopes of their returning have long since been given up". (She had obviously given up hope - she had remarried!)

Some interesting personal items can be found in wills & inventories of estates. The wills of Benjamin Bowers (13 Sept. 1773) and his wife Comfort (5 Dec. 1782) of Swanzey are particularly interesting as they were a well to do family. Benjamin mentions several negros as well as an extensive listing of household items. His wife Comfort lists, among others, 12 eight square turtle shell plates, silver shoe buckles, gold sleeve buttons, gold beads & a locket. She also gives her negro Vilet her freedom when she dies. Many wills mention negro slaves or servants, usually by name. The will of John Bacon, 2 Dec. 1730, requests that his negro girl Dinah be sold and the proceeds be used to buy bibles for his grandchildren. The 1772 will of Leah Bradford of Windham CT mentions "a gold ring which hath my former husband's name theiron", a gold necklace & a gold ring. The first husband she speaks of was Samuel Cook of Windham whose inventory (will dated 1745) mentions a brown wig, a gray wig and a pair of silver sleeve buttons. Anthony Jones of Hopkinton made his will 26 July 1781 "in the 6th yr of American Independence" and mentions "my great coat, silver shoe buckles, my silver stock-buckle & knee buckles". Elisha Silvester's



will dated 17 July 1805 of Scituate, mentions a large silver spoon marked "Z.S. + E.S." which he left to his son Thomas. One can't help but wonder what happened to family heirlooms over the years.

Family differences can also be discovered in wills & probate records. The 1751 will of Nicholas Snow of Rochester MA states "I give & bequeath to my son Prince Snow one shilling lawful money...and the reason I give him no more is his leaving me & his family the way he did". The Freeman family also had their problems. On 3 July 1704, John Freeman, who had been requested to give an account of the estate of his brother, Edmund Freeman, testified "whereas I am abused by it and that it hath been said by my cousin Edmond Freeman or some of his family, that it was a pack of lyes". In her will of 12 Nov. 1823, Hannah Hathaway of Berkley was very explicit as to whom she was not leaving a bequest to, "I do not give nor bequeath anything to...my sister...my three brothers...the children of my two brothers...the children of my sister..." - and they are all named!. Hannah Hawkes of Saugus had a change of heart before she signed her will of 15 Dec. 1857. She states "before signing I revoke so much of this will as relates to Rachel Hawkes (sister in law) and Sarah R. Evans and give them nothing".

One of the most interesting wills I have come across is that of wealthy spinster, Lucy H. Eaton of Boston, written 9 Apr. 1930. Her many bequests range from \$2,000 - \$10,000, she even remembered her house servants and a former maid (who was to receive \$2,000). What is most interesting about this will is the genealogical data it contains. Lucy requests her birth date of 30 Nov. 1844 be cut on the back of the monument in the lot where she is to be buried. She gives a blue brocaded vest worn by her great-grandfather Capt. Alden Bass at his wedding in 1766 to the Mass. Society of Mayflower Descendants along with a pair of high heeled brocaded slippers belonging to his wife. To the Mass. Historical Society she gives a letter written by Capt. Alden Bass to his wife from Three Rivers in 1776 together with an account of his capture by the British and his return from Quebec. The Boston Museum of Fine arts was to receive a wax portrait by Rauschman of her grandfather Joseph Eaton who died 8 Feb. 1809 at the age of 35. She leaves money to several institutions in Boston incl. the Young Men's Christian Union of Boston to be used for the Christmas festivities for poor children & rides for invalids and the Society for the Prevention of Cruelty to Children.

Often mentioned in wills are burial grounds and church pews. In his will of 1765, Jacob Dingley of Duxbury bequeaths "to the inhabitants of Duxborough the privilege to bury their dead in the burying place on my farm". Job Drew of Halifax MA, in his will of 12 May 1832, asks that "my body be buried in the Kingston burial ground where are buried several of my children." Richard Sparrow of Eastham (will dated 28 Jan. 1774) leaves his pew in the meeting house to his son Isaac, but he his to "allow my daughter Hannah to set in it if she is so minded". Joseph Cole of Eastham, in 1790, bequeathed one quarter of his pew in the meeting house to three daughters and two granddaughters (did they have to take turns?).

John Hazell of Rehoboth covers it all in his will of 17 7mth 1651, "I give unto every one that can make it apeere that they are my kindred twelve pence a peece if they shall demaund the same".

Pilgrim Progress

The march of the Pilgrims to church was described in detail by Isaack de Rasieres, a Dutchman who visited Plymouth in 1527. Based on his description, in 1921 the Town of Plymouth established the traditional "Pilgrim Progress". Since that time, on every Friday in August and at Thanksgiving, volunteers have donned Pilgrim garb and re-enacted

the Sabbath procession of the Pilgrims to worship. Many of us who attend the Triennial Congress are given the opportunity to wear a costume and march in our ancestor's place.

Unfortunately, this wonderful tradition may become a thing of the past. The authentic looking Pilgrim costumes are old and many are literally falling apart. While some can be mended, many need to be completely replaced. The estimated cost per costume is \$125, which includes a skirt, bodice, dickie, apron & coif for the ladies and breeches, doublet, cuffs & ruff for the men.

Donations are desperately needed to carry out this restoration. Mayflower Society members are asked to help keep the memory of their Pilgrim ancestors alive. Your contribution (however small) will ensure that the Pilgrim Progress continues to honour our ancestors, otherwise it may cease and become a forgotten memory.
